To advance, improve, develop and maintain public education in, and appreciation of, the art and science of early music in all its aspects including the presentation of public concerts and recitals.

As Trustees we keep in mind the guidance issued by the Charity Commission on public benefit. We aim to promote, sustain and increase individual and collective knowledge and understanding of early music.

The focus of our activities remains the organisation of early music workshops catering for a range of interests and abilities. The workshops are all led by highly-regarded specialist tutors.

We welcome everyone who wishes to come to our workshops. We are especially keen to attract younger people. Our fees for workshops and membership are modest, and concessions are available for families and students.

We seek to provide for those who are experienced in singing and playing early music and wish to explore more complex areas, and for those who have little experience but want to know more.

We organise occasional concerts associated with the workshops, so that those who enjoy listening to early music but do not sing or play are also catered for.

We offer funding to other organisations in our area for innovative ventures that are aimed at increasing the public appreciation of, and participation in, early music.

We publish an entertaining and informative quarterly newsletter and maintain an attractive and useful website, with links to other organisations, information about workshops and much else of interest to members and the wider public. We have a Facebook page. We also send regular emails to remind members about workshops and to inform them of other events directly related to BEMMF.

Summary of the main achievements of the charity during the year

Because of Covid restrictions, our workshops during the year were all conducted online, via Zoom. Participants were muted, so whether a workshop was designed primarily for singers or instrumentalists, everyone could take part. We introduced a 'Compare and Contrast' model: each tutor compared versions of a particular text as set by different composers. There were 9 such workshops in the year and they proved very popular, attracting large numbers of participants from all areas of the UK and from other countries. Funding for the events was drawn from voluntary contributions from participants and from BMEMF's surplus funds. Any funds remaining after the tutor's fee and other administrative expenses had been paid were donated to the charity 'Help Musicians UK'.

We gave a grant of £1,000 to The Linnarol Consort of viols towards their production of a CD of 16th century music from the Low Countries.
